Acknowledgement of Sources Reviewers should identify relevant published work that has not been cited by the authors. Any statement that an observation, derivation, or argument had been previously reported should be accompanied by the relevant citation. A reviewer should also call to the editor's attention any substantial similarity or overlap between the manuscript under consideration and any other published paper of which they have personal knowledge. Disclosure and Conflict of Interest Privileged information or ideas obtained through peer review must be kept confidential and not used for personal advantage. Reviewers should not consider manuscripts in which they have conflicts of interest resulting from competitive, collaborative, or other relationships or connections with any of the authors, companies, or institutions connected to the papers. Duties of Authors Reporting standards Authors of reports of original research should present an accurate account of the work performed as well as an objective discussion of its significance. The underlying data should be represented accurately in the paper. A paper should contain sufficient detail and references to permit others to replicate the work. Fraudulent or knowingly inaccurate statements constitute unethical behaviour.

Where there are other people who participated in aspects of the research project, they should be acknowledged or listed as contributors. The author concerned should ensure that all authors with the tools and no scribe is not worth including in a newspaper, and that all co-authors have seen and approved the final version of newspaper and have agreed to the submission of the newspaper. Danger, human or animal. If the work involves chemicals, procedures or equipment which has an unusual danger attached to them, the author must clearly identify these in the manuscript. Error is Fundamental in the published work When an author discovers a significant error or inaccuracy in the published work itself, it is the obligation of the author to promptly notify the Journal editors or publisher and cooperate with the editor to retract or correct paper.
