1. Remove the formatting instructions, e.g. Heading 1 aside the Introduction title
2. Many sentences lack the verb, such as "They usually based on video" instead on "They are usually based on video"
3. The authors' only claim is that their detection system is simple. Actually, it is too simple to make it the result of a scientific investigation. And it is too simple to perform well in trying conditions. Two images may differ not just because somebody has entered the picture, but also because of other conditions (e.g., lighting conditions).
4. The system's performance should be evaluated more thoroughly.
