- 1. Please improve your introduction section better. Discuss the states of the art related to your topic, as I believe there are many studies have been performed related to KMS development for SMEs.
- 2. I suggest the authors reorganizing their paper to demonstrate the contribution of each section. I suggest this paper is reorganized as follows: Introduction, Literature Review, Research Methods, Results and Discussion, Conclusion.
- 3. In the Research Method, please discuss the key informants to interview, the instruments, and the method for processing the data.
- 4. The results and discussions are shallow. The authors should discuss their KMS design in detail. For example, what is the knowledge that you want to manage in this system? What are the infrastructure (application, software, people, etc) required to develop this system? Etc. In current form, the information is too little.
- 5. What are the KM processes that the authors want to implement in this research? I expect the authors also present the screenshots of each KM process.

Please elaborate on these.
